<b>Name of the authority</b>	Office of the Assistant Commissioner, Goods and Services Tax, Guwahati Division I
<b>Nature and details of the action(s) taken, initiated or order(s) passed</b>	This is in reference to DRC-07 (Assam) issued under Section 73 of the CGST Act, 2017 for the financial year 2020-21. The officer issued a Show Cause Notice (SCN) demanding a tax amount of ₹27,13,864. Despite the explanations provided during the hearing, the Assistant Commissioner raised a revised tax demand of ₹16,84,093 (IGST), excluding interest and penalty of ₹1,68,409, for excess availment of Input Tax Credit (ITC) in GSTR-3B compared to GSTR-2A, totaling ₹18,52,502. The Company is evaluating the option of filing an appeal as well as rectification.
