## Menacing Manu, sensational Sen off to solid starts on day 1

No Olympic medal in shooting since 2012; Bhaker well placed

PRESS TRUST OF INDIA Chateauroux/Paris, July 27

MANU BHAKER MADE a statement of intent by storming into the 10m air pistol finals on a day when most of her compatriots endured a forgettable outing at the shooting range before shuttler Lakshya Sen and paddler Harmeet Desai dazzled on debut in India's sedate start at the Olympic Games on Saturday.

Bhaker, who is competing in her second Olympics, seemed determined to wipe off the memories of her tearful past outing as she qualified third for the 10m air pistol women's final which will be held on Sunday afternoon at the Chateauroux Shooting Centre.

### Harris makes it official; gap with Trump narrows

**VICE PRESIDENT KAMALA** Harris on Saturday officially signed her forms, declaring her candidacy for the post of President of the US and voiced confidence that she would win the highstakes election on November 5. "Today, I signed the forms officially declaring my candidacy for President of the United States. I will work hard to earn every vote," 59-year-old Harris, who is of Indian and African origin, said. "In November, our people-powered campaign will win," the presumptive Democratic Party candidate said, referring to her electoral battle with former president and the Republican Party's nominee Donald Trump. Harris launched her presidential campaign last Sunday, hours after President Joe Biden, 81, withdrew from the race for a second term. She is, however, yet to be officially declared as the presidential can-

didate by the Democrats. If elected on November 5 to succeed President Biden, Harris would not only be the first woman, but the first Indian-American, the first Asian, the first Black woman and the first person of Jamaican descent to ascend to the office. Harris has narrowed the gap with Donald Trump. An NYT/Siena poll found that Harris had closed the gap by 6 or 7 percentage points, depending on whether third parties are included. Her gain comes largely from parts of the Democratic coalition that had soured on Biden.

## South China Sea lines critical for Indo-Pacific peace: EAM

PRESS TRUST OF INDIA Vientiane (Laos), July 27

**EXTERNAL AFFAIRS MINISTER** S Jaishankar on Saturday stressed the need for a substantive and effective code of conduct to secure sea lines of communication in the South China Sea which he said are critical for peace and stability of the Indo-Pacific region, amidst growing concerns about China's maritime coercion.

Addressing the 14th East Asia Summit (EAS) Foreign Ministers Meeting in Laos's capital Vientiane, Jaishankar said the EAS process will complete two decades next year and India will contribute towards a stronger EAS process. He said India will continue to uphold ASEAN unity and centrality through our Act East Policy.

Talking about maritime security, Jaishankar said: the "Sea Lines of Communication (SLOC) passing through the South China Sea are critical for peace, stability, prosperity and development of the Indo-Pacific

region." SLOC is a term describing the primary maritime routes between ports, used for trade, logistics and naval forces. The "Code of Conduct should be substantive and effective, consistent with international law and should not prejudice legitimate rights and interest of nations not party to discussions," he said.

Jaishankar's comments hold significance as his Chinese counterpart Wang Yi is also in Vientiane to attend the summit. The resource-rich South China Sea in the Indo-Pacific region is widely seen as a potential flash point for global conflict.

China claims most of the South China Sea as its own, while The Philippines, Vietnam, Malaysia, Brunei and Taiwan have counterclaims over the maritime area. The South China Sea provides shipping routes connecting Northeast Asia with Southeast Asia and West Asia. Southeast Asian countries are trying to reach an agreement with China on a code of conduct to avert confrontations in the South China Sea.

## Blinken chides Beijing's 'unlawful actions' in South China Sea

**US SECRETARY OF State Antony** Blinken criticised Beijing's "escalating and unlawful actions" in the South China Sea at a summit on Saturday, where his Russian counterpart said Washington has stoked anxiety in its plan for a nuclear deterrence with ally Seoul for the Korean peninsula.

Blinken singled out China over its coast guard's hostile actions against US defence treaty ally the Philippines in the South China Sea, but also lauded the two countries for their diplomacy after Manila completed a resupply mission earlier on Saturday to troops at a disputed shoal, unimpeded by China.

Blinken was attending the security-focused ASEAN Regional Forum on Saturday alongside diplomats of major powers including Russia, India,

Blinken singled out China over its coast guard's hostile actions against US defence ally, the Philippines, in the sea

China, Australia, Japan and the EU, which included discussions on the conflicts in Gaza and Ukraine, North Korea's nuclear ambitions and tension in the South China Sea. The Philippines'small troop presence on a grounded former US navy ship at the second Thomas Shoal has for years angered China, which has clashed repeatedly with the Philippines over its resupply missions, causing regional concern about an escalation that could potentially lead to US intervention. The two sides this week reached an arrangement over how to conduct those missions. "We are pleased to take note of the successful resupply today of the Second Thomas shoal,"Blinken told foreign ministers of the ASEAN in Laos.

Blinken held talks with Chinese Foreign Minister Wang Yi on the sidelines, in their sixth meeting since June 2023, when Blinken's visit to Beijing marked an improvement in strained ties between the countries.


